SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
HOPE CREEK GENERATING STATION

Dear Mr. Braun:

By letter to the U.S. Nuclear Regulatory Commission (NRC) dated March 20, 2015, PSEG Nuclear LLC (PSEG) submitted a Global Nuclear Fuel – American, LLC (GNF-A) affidavit dated October 21, 2013, executed by Mr. Lukas Trosman (Enclosure 3 to PSEG's letter). PSEG requested that the information contained in Enclosure 1 to its letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390. Specifically, PSEG requested that the following be withheld:

Core Operating Limits Report, Reload 18, Cycle 19, Revision 10 - Proprietary

A nonproprietary copy of this document (Enclosure 2 to PSEG's letter) has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the NRC Library in the Agencywide Documents Access and Management System (ADAMS) under Accession No. ML15079A091.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GNF-A's competitors without license from GNF-A constitutes a competitive economic advantage over other companies.
- (4)b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents.
