
Pursuant to the requirements of 10CFR50, Appendix E, Section VI, parts 3.a and 3.b, the following is a notification of the modifications to be implemented on the Emergency Response Data System for the Duke Power Company, Oconee Nuclear Station Unit 1 (ONS Unit-1) and ONS Unit-3

1. Plant Attribute Library (PAL)

The Plant Attribute Library information (PAL) for ONS-1 and ONS-3 will need to be revised in order to reflect the data transmission rate of 15 seconds. ONS-2 will be converted to a 15 second transmission rate in the spring of 1998. All other communication protocols, messages, quality codes, and formats are unaffected by this modification.
