The purpose of this memorandum is to close out the work of the Peer Review Team for the USI A-46 effort for the Emergency Power System (including the Relay Review for the Emergency Power System) for Oconee Nuclear Station. This portion of the A-46 effort includes Keowee Hydroelectric Station and the overhead and underground power paths up to Oconee current transformers CT1, CT2, CT3, and CT4. Please reference my letter of October 14, 1996, to R. L. McCoy which listed items of concern and items for confirmation in the A-46 resolution effort.

Final answers to the concerns of the Peer Review Team with regard to the Emergency Power System were provided in R. L. McCoy's letter of December 4, 1996. Members of the Peer Review Team have reviewed the responses to their concerns and are satisfied with the resolutions to those concerns provided by the Oconee Project Team. The consensus of the Peer Review Team is that the requirements and intent of the Generic Implementation Procedure (GIP) for Seismic Verification of Nuclear Plant Equipment Revision 2, Corrected Feb. 4, 1992, have been met with respect to the Emergency Power System at Oconee Nuclear Station (for the scope described above). The work of the Peer Review Team is complete for the Emergency Power System.
