In accordance with Management Directive 8.8, "Management of Allegations," dated November 15, 2010, the Agency Allegation Advisor is to offer the Executive Director for Operations an independent annual report analyzing allegation trends. A copy of the annual trends report for calendar year 2014 is enclosed.

The report analyzes national, regional, and site-specific trends in allegation data. From a national perspective, the number of allegations received last year decreased by about 11 percent, and over the last five years the numbers have trended down by about 25 percent. Although facility- or vendor-specific matters do play a significant role in allegation trends, anecdotal information suggests that the overall decline could be the result of increased efforts by the U.S. Nuclear Regulatory Commission (NRC) and nuclear industry to focus attention on developing and maintaining stronger environments for raising concerns at regulated entities. The analyses also provide insights into the safety conscious work environment at one operating reactor site, one reactor site under construction, one materials facility, and one vendor site. In cases where the trends are indicative of a weakening safety conscious work environment, the NRC staff has engaged the licensee and is closely monitoring its activities to address the weaknesses.
