**SUBJECT: PLUS, LLC, REQUEST FOR ADDITIONAL INFORMATION CONCERNING
APPLICATION FOR A NEW LICENSE**

Dear Mr. Gupta:

This letter refers to your application dated October 1, 2014, and received by our office on October 28, 2014. In reviewing your application, we found that additional information is required.

10 CFR 32.14 requires the applicant submits sufficient information regarding the product pertinent to evaluation of the potential radiation exposure, please submit the following information:

1. Submit the details of construction and design of each product;
2. The method of containment or binding of the byproduct material in the product;
3. The proposed method of labeling or marking each unit, except timepieces or hands or dials containing tritium, and its container with the identification of the manufacturer or initial transferor of the product and the byproduct material in the product;
4. The radiation level and the method of measurement;
5. Provide distribution methods when using internet service providers, e.g. Amazon, eBay.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the NRC may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).
