The purpose of this modification is to obligate funds in the amount of \$7,375.44 on line item 00001, thereby increasing the obligated amount on line item 00001 from \$1,000.00 to \$8,375.44, and to obligate funds in the amount of \$49,624.56 on line item 00002, thereby increasing the obligated amount on line item 00002 from \$56,973.36 to \$106,597.92.
