Northwest Design Group (NDG) holds a Material License (#21-26560-01).

The owner of NDG, Mr. Howard Haselschwardt, passed away in 2014. His wife, Mrs. Sarah Haselschwardt, who has never been involved in the business, has recently sold the business.

We are providing this letter to you to confirm that these events do not require any changes to the Materials License. Details of the events:

- Mr. Haselschwardt passed away in August of 2014.
- The new owner of the business is Northwest Design Group, LLC, a Michigan LLC (FEIN: 47-3431697). This LLC is 100% owned by Kingscott Associates, Inc., an engineering firm headquartered in Kalamazoo, Michigan. The LLC has purchased all of the assets of NDG used in NDG's business. The business will continue to operate as it has historically operated.
- The business will continue to operate under the names "Northwest Design Group" and "NDG."
- The location of the business is not changing and will remain at 2940 Parkview Drive, Petoskey, Michigan 49770.
- The Radiation Safety Officer (RSO) is not changing and will still be Daniel W. Ulrich. His contact information (noted at the end of this letter) is not changing.
- There will not be any personnel changes in connection with these events. The personnel of NDG with responsibility and authority for the Materials License and related customer projects are not changing.

- Except for the change in the name of the licensee (from Northwest Design Group, Inc. to Northwest Design Group, LLC), none of the information in the Materials License is changing.
