This acknowledges receipt of your letter dated April 14, 2015, reporting an incident that occurred on January 19, 2014, in which a generator shield, Serial Number 2116, containing 299.7 megabecquerels (MBq) (8.1 millicuries (mCi)) of depleted uranium (DU) failed to make it back to the Mallinckrodt facility and has been considered to be lost by the courier. The U.S. Nuclear Regulatory Commission (NRC) has reviewed your letter and its attachments and has no further questions at this time. The incident will be examined during a future inspection.
