The Board decision denied their petition to intervene and for a hearing on the amendment to the operating license for the Perry Nuclear Power Plant.

All Commissioners have approved an order attached to the SECY memo dated September 29th which grants the appeal and reverses the Licensing Board's denial of the intervention petition. The petitioners' contention is remanded to the Licensing Board for further proceedings to address its adequacy.
