On March 27, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Peach Bottom Atomic Power Station, Units 2 and 3. The NRC inspectors discussed the results of this inspection with Mr. Mike Massaro, Site Vice President, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
