Subject: RAI concerning new AU/RSO

Discussion: In the letter dated March 26, 2015, the licensee requested that Jeffrey Bath, MD be added as an AU and the RSO. I spoke with Ms. Benson and informed her that Dr. Bath would need to be listed as an AU on their license before he could be added as the RSO. She stated that Dr. Scott Smith will be staying at the facility for the time being and is willing to remain the RSO. Therefore, add Dr. Bath as an AU and keep Dr. Smith as the AU and RSO. Following Dr. Bath being named as an AU, the licensee will submit an amendment request to change the RSO from Dr. Smith to Dr. Bath.

In addition, on 4.22.15 I spoke with T. Carpenito of the Mass. Radiation Control and confirmed that Jeffrey Bath, M.D. was an AU on the North Adams Regional Hospital within the last 7 years.
