The purpose of this modification is to obligate funds in the amount of \$239,974.70, thereby increasing the total obligations from \$746,697.00 to \$986,671.70, and to add Michael Benson as the Alternate Contracting Officer's Representative (COR).

Accordingly, the task order is modified as follows:

1. The first sentence of paragraph (c) under section b.4, CONSIDERATION AND OBLIGATION-TASK ORDERS, is revised to read as follows:

"(c) The amount presently obligated with respect to this order is \$986,671.70, of which \$951,671.70 is obligated for Labor Cost, and \$35,000 is obligated for ODCs & Travel."
