By letter dated March 27, 2015, Louisiana Energy Services, LLC (LES) submitted a license amendment request (LES-15-00060-NRC) (Agencywide Document Access and Management System [ADAMS] Accession No. 15090A315) to the U.S. Nuclear Regulatory Commission (NRC) for review and approval of the revision to its Enrichment Technology US Inc. (ETUS) System Security Plan (SSP), specifically, the Hot Acceptance Test Computer System SSP.

In its March 27, 2015, letter, LES also stated that it is making a re-accreditation request for the aforementioned SSP in accordance with the provisions of the U.S. Department of Energy (DOE) Program Cyber Security Plan Version 2.0.

As part of the screening process, the NRC staff has completed the review of the information that LES submitted, and found the information acceptable for detailed review. During this review, we will notify you if any additional information, or clarification of existing information, is needed. The staff efforts associated with this review will be charged to Technical Assignment Control (TAC) number L34318. Please reference this TAC number in all correspondence related to this action.

Based on our preliminary review and projection of current review schedules, we anticipate completing our review of your request by September 2015. This date could change depending on the findings of our technical/administrative review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
