#### Status of Recommendations

Recommendation 1: Clarify and disseminate expectations for generating and maintaining supporting documentation for performance data to staff responsible for preparing and collecting performance data.

Agency Response  
Dated March 26, 2015:

The formal Business Process Improvement project on Performance Management was completed in the 3<sup>rd</sup> quarter of fiscal year 2012. A draft Management Directive (MD) and the Federal Handbook (HB) for "*Performance Management*" was developed to help better align NRC's policies with government laws and regulations such as the Government Performance Results and Modernization Act of 2010. This draft was further updated to better align with the new Strategic Plan and guidance provided in the Office of Management and Budget Circular No. 11. The MD was sent to all offices and the Office of the Inspector General in December 2013 for comment. After comments were received the final document was developed. The MD and HB were delivered to the Office of the Secretary (SECY) in June 2014.

The Chairman's office returned both the MD and HB to the Office of the Executive Director for Operations (OEDO) as disapproved. The Chairman's office recommended that the Office of the Chief Financial Officer (OCFO) and OEDO work together to gain alignment in the areas where the MD's overlap in planning, budget and performance management and to make sure they are fundamentally integrated and that the processes are clear and complete. The OEDO is working with OCFO to gain further alignment and resubmit the Performance MD and HB to the Chairman and SECY by December 15, 2015. (COMSECY-14-0026)

OIG Analysis:
