### DESCRIPTION OF MATERIALS OR FACILITIES

This license authorizes the export of 6,777 kilograms (kg) of thorium contained in 9,000 kg of thorium fluoride, enriched to 75.3 WGT % maximum, in granular form.

This license is amended to: 1) increase the quantity authorized for export by 4,477 kg of thorium contained in 6,000 kg of thorium fluoride, to a new cumulative total of 6,777 kg of thorium contained in 9,000 kg of thorium fluoride; 2) change the licensee point of contact; and 3) extend the date of expiration from January 1, 2018 to January 1, 2025.
