Meeting Summary

April 22, 2015 Public Meeting between NRC staff and representatives of the Low-Level Waste Forum Working Group on Disused Sources (DSWG)

Purpose:

The purpose of the meeting was to provide an information exchange regarding DSWG topical survey and NRC initiatives relevant to both organizations.

Summary:

The meeting was convened at the request of representatives of the Low-Level Waste Forum DSWG, who wished to continue a dialogue with representatives of the Division of Materials, Safety, States, Tribal, and Rulemaking (MSTR) and the Division of Decommissioning, Uranium Recovery and Waste Programs (DUWP) concerning the end-of-life management of radioactive sealed sources.

Larry Camper, Director, DUWP, opened the meeting by thanking the participants and briefly discussing DUWP initiatives relevant to end of life management of radioactive sealed sources, particularly the byproduct material financial scoping study.

A representative of the DSWG discussed preliminary results of the recent Conference of Radiation Control Program Directors (CRCPD)/DWSG questionnaire sent to state radiation protection control program directors. The questionnaire offered respondents the opportunity to comment regarding recommendations contained in the DSWG March 2014 report. Results of the survey will soon be publicly available.

Ray Fleming, DSWG, reminded participants of some of the key recommendations in the March 2014 report.

DSWG also noted the following items:

- The “in storage” box, in the National Source Tracking System (NSTS), should be mandatory.
- Licensees are keeping sources because it is expensive to dispose of them.
- Americium, used in well logging, is quite messy to clean up when it contaminates the soil.
- Economic impact of radiological dispersal devices should be included in cost studies for the disposal of sources.
- Texas has a 2 year limit storage regulation.

Adelaide Giantelli, Chief, Source Management and Protection Branch, noted that NRC is working on a self assessment of the effectiveness of 10 CFR Part 37. The staff will provide the results of this effectiveness review and recommendations to the Commission when complete. Several issues with disused sources are also issues to be addressed in this effectiveness review so close coordination between MSTR and DUWP on initiatives related to end-of-life source management is warranted.

Both NRC staff and the DSWG agreed that both organizations should work closely together and continue dialogue on issues of mutual interest related to management of radioactive sealed sources.
