On April 2, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at the Callaway Plant, and the NRC inspectors discussed the results of this inspection with Mr. L. Graessle, Senior Director, Operations Support, and other members of your staff. The inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspector did not identify any findings or violation of more than minor significance.
