SUBJECT: URS CORPORATION, CONSENT TO TRANSFER NRC LICENSE,
MAIL CONTROL NO. 584947

Dear Mr. Hollaway:

By letters dated September 19, 2014 (ML14275A271) and October 16, 2014 (ML14300A229), URS Corporation (URS), the holder of NRC materials license number 37-19654-01, submitted to the U.S. Nuclear Regulatory Commission (NRC) a request for approval of an indirect transfer of control and a license amendment to change its name on the license. URS provided information required by 10 CFR 30.34(b) pertaining to a transfer of control. URS has entered into a merger agreement with AECOM Technology Corporation (AECOM) in which URS will ultimately merge with and into ACM Mountain II, LLC, a direct wholly-owned subsidiary of AECOM. URS will survive the merger as a direct wholly-owned subsidiary of AECOM and will be renamed AECOM Global II, LLC. As a result of the name change, URS has requested approval of license amendment for the name change upon approval of the transfer of control and consummation of the merger agreement.

In its September 19, 2014, letter, URS stated that other than the name change there will be no change with respect to the license or licensed activities, including personnel having control over licensed activities and the use, possession, location, and storage of licensed materials. Based on the above understandings, and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, the NRC consents to the proposed indirect transfer.

Please note that you will need to notify the NRC promptly, in writing, after the transaction has been finalized and include signed documentation of the completion of the action. With this information, we can issue an administrative amendment to your NRC license to reflect the transaction and name change. Please notify the NRC, in writing, if this planned transaction has not been consummated within 30 days of the date of this letter or this consent may be deemed null and void. Please contact me at 610-337-5216, or by e-mail at craig.gordon@nrc.gov if you have any questions regarding this letter.

Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material would require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.
