This refers to your license amendment request dated January 19, 2015. Enclosed with this letter is the amended license transferring the facilities, equipment, and materials of Hartford Hospital's location at Farmington Medical Arts, Twin Building B, 11 South Road, Suite 100, Farmington, Connecticut under NRC License No. 06-00253-04 to the Molecular Imaging Services, Inc. license. This is being issued concurrent with the removal of this location from the Hartford Hospital license under Mail Control Number 585982. This amendment also adds Brett Duncan, M.D. and Melissa Ferraro-Borgida, M.D. as authorized users, and the use of Gadolinium-153 permitted by 10 CFR 35.500.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
