Dear Mr. Karaba:

On April 10, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your LaSalle County Station, Units 1 and 2. On April 16, 2015, the NRC inspectors discussed the results of this inspection, with Mr. Harold Vinyard, Plant Manager, LaSalle County Station, Units 1 and 2, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

NRC inspectors documented two findings of very low security significance (Green) in this report. These findings involved violations of NRC requirements. The NRC is treating these violations as non-cited violations (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest these violations or the significance of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region III; the Director, Office of Nuclear Security and Incident Response; the Director, Office of Enforcement, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC resident inspector at the LaSalle County Station, Units 1 and 2.

If you disagree with a cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region III, the Director, Office of Nuclear Security and Incident Response; and the NRC resident inspector at the LaSalle County Station, Units 1 and 2.
