This letter is in reference to the petition for rulemaking (PRM), dated March 13, 2015, that you filed electronically with the U.S Nuclear Regulatory Commission (NRC). Your PRM is available in the NRC's Agencywide Documents Access and Management System under Accession No. ML15113B143. You request that the NRC amend its requirements in Part 50 of Title 10 of the *Code of Federal Regulations* (CFR), "Domestic licensing of production and utilization facilities," regarding the use of in-core temperature monitoring at nuclear power plants. The NRC docketed your petition pursuant to 10 CFR 2.802, "Petition for rulemaking," on April 24, 2015, and assigned it Docket Numbers PRM-50-111 and NRC-2015-0124.
