On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to your letter of April 20, 2015, forwarding correspondence from your constituent Mr. Jay Gupta. Mr. Gupta requested your support in obtaining a status update on Plus, LLC's October 1, 2014, application for licenses to store and distribute wristwatches that contain radioactive material.

Mr. Gupta submitted applications for two separate licenses – one for possession and another for distribution of licensed radioactive material in the U.S. The possession license is to ensure the safe use, storage, and transport of radioactive material; the distribution license is to ensure the products containing radioactive material are safe for use by consumers who are not required to have a license under the NRC's regulations. Receipt of these licenses is required before an applicant can either possess or distribute the radioactive material.

NRC's Region I office is responsible for review and approval of the possession license. That license was issued on April 23, 2015.

NRC headquarters is responsible for review and approval of the distribution license. Additional information regarding the application is required for us to complete our review, therefore, we issued a request for additional information to the applicant on April 27, 2015.

The NRC was aware prior to receipt of the Plus, LLC license applications that the applicant had been possessing and distributing these products without the required licenses. Because Plus, LLC apparently was not in compliance with NRC regulations, the agency has needed additional time, over and above the normal application processing time, to examine and evaluate the situation.
