Thank you for your email of October 3, 2012, regarding the study plan for proposed wildlife baseline surveys at the Rare Element Resources Bull Hill Mine and Upton Plant project sites (Project). The Bull Hill Mine will be located in all or portions of Sections 5, 7-10, 15-18, 20, and 21, T52N, R63W in Crook County, Wyoming. The Upton Plant will be located in all or portions of Sections 20, 28, 29, 32, and 33, T48N, R65W in Weston County, Wyoming.



Based on the information provided, it is unlikely that the proposed work will adversely affect any threatened or endangered species. You may consider this project, as proposed, to be in compliance with the Endangered Species Act of 1973, as amended (Act), 16 U.S.C. 1531 *et seq.*

Your proposed wildlife baseline studies plan methodology is in accordance with standard biological practices and takes into account the particular species of concern and threatened and endangered species likely to occur within or near the Project area. The Service would appreciate a copy of your Project-specific wildlife baseline report once it becomes available. Additionally, we would appreciate being notified when additional plans are considered for this Project and other similar projects.

This Project should be re-analyzed if new information reveals effects of the action that may affect listed species or designated or proposed critical habitat in a manner or to an extent not considered in this letter; if the action is subsequently modified in a manner that causes an effect to a listed or proposed species or designated or proposed critical habitat that was not considered in this letter; and/or if a new species is listed or critical habitat is designated that may be affected by this project.
