Dear Ms. Lampert,

I am responding to your January 30, 2015, e-mail to Mr. Raymond McKinley, Branch Chief in the Region I Division of Reactor Projects, which contained Pilgrim Watch's comments and questions regarding Entergy's Flex Mooring Plan.

There is a process associated with each licensee's compliance with Order EA-12-049. Pilgrim developed their proposed Flex Mooring Plan and is now in the process of validating the feasibility of their Flex Mooring Plan. In accordance with the Order, Pilgrim is expected to come into compliance by the end of their Spring 2015 refueling outage. Pilgrim will formally notify the NRC of their compliance with Order EA-12-049, after which the NRC will complete their review and issue a safety evaluation. The safety evaluation will likely be completed in 2015. After the NRC's safety evaluation is issued, the NRC will perform an independent inspection to verify Pilgrim's compliance with Order EA-12-049. This inspection will be conducted in accordance with Temporary Instruction (TI) 2515-191, "Inspection of the Implementation of Mitigation Strategies and Spent Fuel Pool Instrumentation Orders and Emergency Preparedness Communication/Staffing/Multi-Unit Dose Assessment Plans."
