Enclosed is Amendment No. 4 to your NRC Material License No. 21-32508-01 in accordance with your request. Changes made to your license are printed in **bold** font.

Please review the enclosed license amendment document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9892 so that we may provide appropriate corrections and answers.

In letter dated March 26, 2015, you provided final close-out information for facilities located at 1350 E. Main Street, Suite 100, Owosso, Michigan, listed on the above referenced license. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the CIMA Heart Institute, P.C. (formerly Owosso Heart Institute) facilities and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
