Subject: Request Amendment to Correct Condition 13 on License

Dear Ms. Pelke:

1. We need to have Condition 13 of our license updated to allow distribution of our I-125 RIA kits to generally licensed facilities under 31.11. We do not wish to distribute to exempt facilities. To confirm, we request the authority to distribute I-125 RIA kits for in vitro clinical or laboratory testing to generally licensed facilities.
2. We have been inspected by NRC inspectors on several occasions without this being an issue.
3. Our current license application should contain all of the requirements to support this request. The following information is provided to confirm the basic application information:
  - a. Radioactive material will be possessed, manufactured, and distributed from the address at 6 Research Park Drive, St. Charles, MO 63304.
  - b. We will distribute only I-125 RIA kits for in vitro clinical or laboratory testing to generally licensed facilities. The RIA kits will contain I-125 bound material packaged and prepared for the facilities' use.
  - c. The Authorized Users and RSO are listed on the current license.
  - d. We ship all radioactive material from our facility as UN2910 limited quantity radioactive material. The largest individual kit we manufacture contains less than 5 uCi.
4. We have operated under this license for numerous years and have been paying the NRC fees for the privilege of distributing this material.
