To Whom it May Concern:

Thank you for providing the Florida State Historic Preservation Officer with the opportunity to comment on the Draft Environmental Impact Statement (DEIS) for the Turkey Point Units 6 and 7 combined license application. Pursuant to a letter from NRC dated October 23, 2014, I note that the U.S. Army Corps of Engineers is now the lead federal agency for compliance with Section 106 of the National Historic Preservation Act of 1966, and that the Section 106 process will not be completed through the completion of this NEPA document.

I agree with the DEIS review team's conclusion that the impacts from the construction and preconstruction activities of Units 6 and 7 will be small (and therefore unlikely to impact cultural resources listed on or eligible for listing on the National Register of Historic Places, or NRHP). I also agree that the impacts from the construction and preconstruction activities for the proposed transmission lines and other offsite activities have the potential to adversely affect eligible NRHP resources.

In a letter to the Corps' Miami Permits Section dated April 2, 2015 (DHR #: 2015-1221), our office requested that all previously unsurveyed portions of the offsite APE be subjected to professional archaeological survey and that the resultant report be submitted to us in order to facilitate Section 106 review. I look forward to continuing Section 106 consultation with the Corps of Engineers to assess effects to the resources within the area of potential effects, and to consult on any necessary avoidance, minimization, or mitigation strategies that might be necessary.
