Dear Mr. Teahon:

By letter dated April 27, 2015 (Agencywide Documents Access and Management System (ADAMS) accession # ML15131A028), Cameco Resources Crow Butte Operation (Cameco) submitted a response to a request for additional information (RAI) for license condition (LC) 11.11 to the U.S. Nuclear Regulatory Commission (NRC) staff transmitting a proposed schedule for completing the RAI. This letter requests additional details on Cameco's proposed schedule for responding to the RAI.

LC 11.11 requires the submittal of the details of Cameco's airborne effluent and environmental monitoring program as well as additional details on public and occupational exposure monitoring. The NRC staff requires this information to complete its assessment of Cameco's demonstration of compliance with applicable regulatory requirements. Please provide the NRC staff with a rationale for not responding to the RAI earlier than July 1, 2015 as indicated in your April 27, 2015 letter.
