On May 7, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Brunswick Steam Electric Plant. The NRC inspectors discussed the results of this inspection with Mr. J. Krakuszeski, and other members of the Brunswick staff. The inspectors documented the results in the enclosed inspection report (IR).

No NRC-identified or self-revealing findings were identified during this inspection.
