SUBJECT: FAILURE TO IDENTIFY AN INTERMEDIATE CONSIGNEE ON EXPORT
LICENSE XCOM1093/04 – NON-CITED VIOLATION OF 10 CFR 110.32(d)

Dear Ms. Gutman:

This letter refers to your voluntary self-disclosure letter dated April 29, 2015, regarding your failure to include an intermediate consignee on the license application in accordance with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Section 110.32(d). Specifically, between December 4, 2009, and February 28, 2012, nine shipments of components under the U.S. Nuclear Regulatory Commission (NRC) export license XCOM1093 as amended, were shipped to the SKODA JS (SKODA) located in the Czech Republic.

Paragraph 110.32(d) of 10 CFR states that the names and addresses of all intermediate and ultimate consignees are provided in their license application other than intermediate consignees performing shipping services only. Contrary to the above, SKODA was not identified as an intermediate consignee on XCOM1093, as amended, and nine shipments were made to SKODA who performed work on the components beyond shipping services.

Based on the information provided, the NRC has determined that a Severity Level IV violation of NRC requirements occurred. In your letter dated April 29, 2015 (withheld from public disclosure under 10 CFR 2.390), you explain that Westinghouse reviewed its export procedures. Westinghouse took corrective measures to amend the license to include SKODA and measures were identified to prevent its reoccurrence in the future.

This violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is available on the NRC's Web site at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation is being treated as a Non-Cited Violation (NCV) because all the criteria in Section 2.3.2 of the NRC's Enforcement Policy were met: (1) you identified the violation, (2) you initiated prompt and comprehensive corrective actions to prevent recurrence as documented in your letter dated April 29, 2015, (3) the violation was not repetitive as a result of inadequate corrective actions, and (4) the violation was not willful.
