In the letter you will need to confirm that you have not possessed anything under this item, and that you will not possess any such material exceeding exempt quantities (per 10 CFR 30.18/30.71) or exempt concentrations (per 10 CFR 30.14/30.70).

If this is what you plan to request, I believe we should be able to amend the license to remove Section E from the license. I will let you know if I find out otherwise.

Also, I received your phone message from Monday. Is the question below the one you meant to ask by phone, or is there another correction/change needed for the license.
