Dear Mr. Howard:

Enclosed is Amendment No. 25 to your NRC Material License No. 24-32517-01 in accordance with your request. Please note that the changes made to your license are printed in bold font.

As discussed with you on May 6, 2015, you agreed not to add Dr. Waller and Dr. Canavan to the your license for the use of 10 CFR 35.300 materials at this time because the licensee will need more time to gather additional information regarding their training and experiences required by 10 CFR 35.390. In addition, we did not add Dr. Canavan to your license for the use of 10 CFR 35.600 materials because her supervising authorized user and her preceptor authorized user listed in the NRC Form 313 (AUS) were not authorized physicians licensed to practice medicine in the U.S., or a Territory of the U.S., or Puerto Rico as defined in 10 CFR 35.2. This action is without prejudice to resubmission.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
