Subject: DTE Electric Company Submittal of Fermi 3 Report of 10 CFR 50.59 Changes, Tests and Experiments, and 10 CFR 52 Appendix E Departure Report

The Nuclear Regulatory Commission (NRC) issued the Fermi 3 Combined License (NPF-95) to the DTE Electric Company (DTE) on May 1, 2015. In accordance with 10 CFR 50.59(d)(2), holders of combined licenses are required to submit a report containing a brief description of any changes, tests and experiments, and summary of the evaluation of each. This report is required to be submitted at intervals not to exceed 6 months until the NRC makes its findings under 10 CFR 52.103(g). During the period from May 1, 2015 to May 14, 2015, there were no changes, tests or experiments made pursuant to 10 CFR 50.59(c).

The Design Certification Rule for the Economic Simplified Boiling Water Reactor (ESBWR), 10 CFR 52 Appendix E, became effective on November 14, 2014. Sections X.B.1 and X.B.3.b. of Appendix E require that applicants and holders of combined licenses referencing Appendix E submit a semi-annual report to the NRC containing a brief description of any plant-specific departures from the Design Control Document (DCD), including a summary of the evaluation of each departure. During the period from November 14, 2014 to May 14, 2015, there were no plant-specific departures from the ESBWR DCD for Fermi 3.
