Dear Ms. Foster:

In accordance with NUREG – 1556, Vol. 15, Appendix F, we are provided written notice of intent to transfer control of Schleede-Hampton Associates, Inc. (SHA) NRC license (transferor) to G2 Consulting Group, LLC (transferee) which is currently authorized to utilize the regulated materials in possession of SHA. We anticipate the official transfer of control (storing of licensed material at G2's licensed Troy facility) will occur in the 1st quarter 2016.

G2 is purchasing the assets of SHA in May 2015 and SHA will become part of G2. SHA will change its name to G2 Consulting Group, LLC. For additional information, please contact Bruce Wilberding, RSO for G2 at 248-680-0400. At this time, Bruce Wilberding will continue to be the RSO for G2's offices in Troy, MI and Ann Arbor, MI, and James Berry will continue to be the RSO for the Birmingham, MI facility (as noted in their license). Once the Birmingham, MI facility is closed in the 1st quarter 2016, Bruce Wilberding will continue as RSO per G2's license. No new personnel will oversee the radiation safety programs for the office. The surveillance program of leak tests and quality control will continue as normal for both facilities. At the time consent is granted, all records concerning the safe and effective decommissioning of the SHA facility will be transferred to G2. G2 will abide by all constraints, conditions, requirements and commitments of SHA. Given G2's facilities are currently licensed to store the same materials stored by SHA now, we anticipate significant changes to G2's licensed program will be minimal.

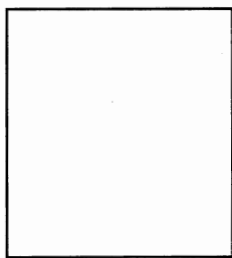

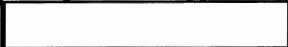
