On February 3, 1998, an Order Imposing Civil and Monetary Penalties was issued against Power Inspection, Inc. of Wexford, Pennsylvania. A Request for Hearing was filed by Paul E. Chambers on March 2, 1998. On March 20, 1998, the Atomic Safety and Licensing Board Panel (Board) issued its Memorandum and Order (Scheduling), which, *inter alia*, granted a hearing and scheduled a telephone prehearing conference.

The NRC staff (Staff) hereby moves the Board, pursuant to 10 C.F.R. § 2.730 of the Commission's Regulations, for an Order postponing the prehearing conference due to the unavailability of Staff counsel.


On March 23, 1998, Staff counsel spoke with Paul E. Chambers via telephone and advised him that a request would be made to postpone the prehearing conference.


