I am writing you to inform you that the proposed asset purchase has been yet again delayed. That said, I would like to formally request that Associated Imaging, Inc. /dba The Imaging Center be permitted to continue to operate under the current license as there has not been any transfer of assets. This is the last possible week to come to an agreement with regard to the transfer of assets. Closing will not occur until July 1<sup>st</sup> or August 1<sup>st</sup> even if an agreement is signed this week.
