The Foundation has gone by several names since it was first established. From 1997 until approximately 2003 or 2004, the Foundation was officially called the William J. Clinton Presidential Foundation. From approximately 2003 to 2013, the Foundation was officially called the William J. Clinton Foundation or the William J. Clinton Foundation, Inc. Since 2013, the Foundation has been officially called the Bill, Hillary & Chelsea Clinton Foundation. This request covers correspondence received from any iteration of the entity described above.

The Clinton Foundation has also been structured into numerous initiatives, including:
