Dear Chief Bladley,

Biscayne National Park is an irreplaceable national treasure that safeguards precious natural resources and recreational opportunities.

Therefore, I write to express my opposition to the proposed expansion of Turkey Point Power Plant, located directly on the shores of Biscayne National Park in an area that is extremely susceptible to sea level rise and the impacts of climate change. The expansion of Turkey Point could have serious environmental impacts on sensitive ecological habitat and the health and sustainability of limited freshwater resources.

Like so many U.S. citizens and residents, I am a frequent visitor to our nation's national parks, and am committed to protecting our country's incredible array of landscapes, waters, wildlife and opportunities for exploration. According to the Nuclear Regulatory Commission's own regulations, "sites adjacent to lands devoted to public use may be considered unsuitable," and unacceptable impacts are "most apt to arise in areas adjacent to natural-resource-oriented areas." Within six miles of the proposed expansion site, there are two national parks, an aquatic preserve, a national wildlife refuge, and a wetland habitat preserve. In following the NRC's own guidelines, the expansion of Turkey Point could have unacceptable and irreversible impacts on these treasured sites.

Operating two new reactors at Turkey Point could also have huge impacts on the quantity and quality of precious freshwater resources. The withdrawal of massive amounts of water from under Biscayne Bay as back-up cooling water could increase salinity levels within the Bay and hasten saltwater intrusion into our limited freshwater supplies.

Furthermore, expanding a nuclear power plant in an area that is ground zero for sea level rise threatens the future of South Florida. I strongly oppose the expansion of Turkey Point as proposed due to the project's potentially widespread negative environmental and public health and safety impacts and the serious threats it poses to Biscayne National Park.

Thank you for considering my request.
