On May 15, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your North Anna Power Station, Units 1 and 2. On May 21, 2015, the NRC inspectors discussed the result of this inspection with Mr. Gerald Bischof, Site Vice President and other members of your staff. Inspectors documented the result of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
