SUBJECT: SUMMARY OF MAY 21, 2015, PUBLIC MEETING ON
IMPLEMENTATION OF NEAR-TERM TASK FORCE
RECOMMENDATION 2.1, FLOODING HAZARD
REEVALUATIONS, RELATED TO THE FUKUSHIMA
DAI-ICHI NUCLEAR POWER PLANT ACCIDENT

On May 21, 2015, the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting¹ with stakeholders. The purpose of the meeting was to discuss the flooding hazard reevaluations that are being performed as part of Recommendation 2.1 from “Recommendations for Enhancing Reactor Safety in the 21st Century,” a report issued by the post-Fukushima Near-Term Task Force (NTTF) on July 12, 2011.² On March 12, 2012, the NRC issued a request for information pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Section 50.54(f) (hereafter referred to as the 50.54 (f) letter) partly to implement this recommendation.³

The NRC staff presented the proposed changes to the NTTF Recommendation 2.1 flooding hazard reevaluation reviews and the path forward as a result of new Commission direction provided by Staff Requirements Memorandum (SRM) to COMSECY-14-037⁴. The Nuclear Energy Institute (NEI) presented the NRC staff with a revised version of NEI 12-06 “Diverse and Flexible Coping Strategies Implementation Guide”; Appendix G⁵. The purpose of Appendix G is to provide guidance to licensees to assess mitigating strategies with respect to the reevaluated flood hazard.
