This is in reference to your letter and renewal application dated December 30, 2014, for Nuclear Regulatory Commission (NRC) License No. 37-23370-01. In order to continue our review, we need the following:

1. A review of your operating and emergency procedures identified that they fail to provide immediate response actions to a ratemeter alarm, per 10 CFR 34.13(d), 10 CFR 34.45. Please provide a revision to your operating and emergency procedures to include what actions should be taken in the event of ratemeter alarm.
2. In your procedures for retrieval and recovery of a source, it is stated that, "All retrievals will be done or supervised by Prime NDT's RSO who has successfully completed the AEA Technology Retrieval Course." However, it is not clear that the RSO will be present at temporary jobsites to perform or supervise the retrieval and recovery of a source. Please provide a revision to your operating and emergency procedures stating that the RSO will be present at the temporary jobsite during retrieval and recovery of a source; or in the case where the RSO cannot be present at the temporary jobsite then another radiographer who has successfully completed the AEA Technology Retrieval Course will be onsite to perform or supervise the retrieval and recovery of a source; or if a trained radiographer in source retrieval and recovery is not available at the temporary jobsite then Prime NDT Inc., will not perform a retrieval and recovery of a source in this situation and will use the services of a person specifically licensed by the NRC or an Agreement State to perform the retrievals of your sources. Further, in your procedures it is stated that, "Not all mobile units will be equipped with every item (in the list above this statement)." Please revise your operating and emergency procedures to state that at a minimum the source recovery safety equipment at a temporary jobsite during the retrieval and recovery of a source shall at least include survey meters, dosimeters, and safety tongs (for picking up source). The radiography present during the time of a disconnect may use whatever shielding is available to minimize the radiation area.

*Your reply must be in writing by letter and signed by a management representative (in this case it may be you since you are both RSO and President). To expedite processing of your renewal application it is recommended that you please return your signed reply letter as a PDF attachment in*
