SUBJECT: SUMMARY OF MEETING TO DISCUSS REQUESTS FOR ADDITIONAL
INFORMATION ASSOCIATED WITH THE REVIEW OF THE
ADVANCED BOILING-WATER REACTOR CERTIFICATION RENEWAL
ON MAY 7, 2015

On Tuesday, May 7, 2015, the U.S. Nuclear Regulatory Commission's (NRC) staff held a meeting from 9:00 a.m. to 4:00 p.m. with members of GE Hitachi Nuclear Energy (GEH) to discuss requests for additional information (RAI) associated with the review of the advanced boiling-water reactor (ABWR) certification renewal. A portion of the meeting was closed due to the proprietary nature of the information discussed. The attached summary is for the portion of the meeting open to the public. This meeting resulted in reaching agreement on GEH's proposed approach to address item numbers 2, 3, 4, 6, 7, 8, 10, 12, 13, 17, 21-24, 26-28 as described in the letter dated July 20, 2012 (Agencywide Documents Access and Management System Accession No. ML12125A385). In addition, agreement was reached on the proposed approach for RAIs associated with the aircraft impact assessment and containment peak pressure analysis. The remaining items in the July letter as well as RAIs associated with NRC Bulletin 2012-01 and the Interim Report regarding containment loads that potentially exceed limits with high suppression pool water level require further discussion with the applicant in order to be dispositioned.
