Enclosed is Amendment No. 23 amending your NRC Material License No. 13-32087-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please note that the two letters you requested to be referenced in license condition 19 were not added. Each letter requested the deletion of an ANP and nothing more. It is NRC's licensing policy to only reference in the last license condition, procedures or other information that is pertinent or relevant to your radiation safety program.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
