On June 4, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Three Mile Island Nuclear Station, Unit 1. On June 11, 2015, the NRC inspectors discussed results of this inspection with Mr. Randy Campbell, site security manager and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
