The Revision Log of the WBN Physical Security Plan, Training and Qualification Plan, Safeguards Contingency Plan, and Independent Spent Fuel Storage Installation Security Program provided in the enclosure describes the recent changes. The revised plan became effective as of April 24, 2015.

Tennessee Valley Authority (TVA) has evaluated the changes contained in this revision and has determined that the revision does not decrease the safeguards effectiveness of the subject plan.


