SUBJECT: SUMMARY OF A PUBLIC MEETING ON JUNE 11, 2015, WITH
MEMBERS OF THE AP1000 DESIGN CENTER TO DISCUSS THE
LEVY COMBINED LICENSE APPLICATION DEPARTURE
ADDRESSING CONTROL ROOM HABITABILITY

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting on June 11, 2015, at 2:00 p.m. with members of the AP1000 design center. The purpose of the meeting was to discuss AP1000 combined license (COL) issues, focusing on the Levy COL departure requests addressing habitability of the main control room (MCR). The departures are described in submittals from Duke Energy Florida (DEF) dated March 26, and June 5, 2015, that responded to requests for additional information (RAIs) from the NRC staff.¹ The list of attendees is enclosed. The meeting notice is available in the Agencywide Documents Access and Management System (ADAMS).² The meeting notice is also posted on the NRC public website.³

The meeting included an open session during which the staff asked questions related to the DEF submittals.⁴

3. NRC will consider formulating an RAI on questions dealing with assumptions of fin obstructions and fin cleanliness and assumptions/justification of how they would affect heat transfer.
4. DEF/Westinghouse Electric Company (Westinghouse) to identify and confirm the availability of analysis related to heat transfer for fins/obstructions/cleanliness/ceiling.
