On March 5, 2015, the U.S. Nuclear Regulatory Commission (NRC) accepted the design certification (DC) application for docketing of the Advanced Power Reactor 1400 (APR1400) submitted by Korea Electric Power Corporation (KEPCO) and Korea Hydro & Nuclear Power Co., Ltd. (KHNP). The NRC staff initiated Phase 1 of the application DC review on March 9, 2015.

The NRC staff has identified a need to conduct a regulatory audit of the documents and supporting calculations related to the evaluation of the APR1400 containment, especially related to the required sub-compartment analyses, containment volumes and water holdup, and the means and supporting containment analyses used to mitigate against a beyond-design-basis external event and comply with Order EA-12-049. The audit will take place at the Westinghouse Office in Rockville, Maryland, from June 29, 2015, through September 30, 2015. A copy of the audit plan is enclosed.
