In Reference 1, the Nuclear Regulatory Commission issued Calvert Cliffs Nuclear Power Plant, LLC (Calvert Cliffs) renewed operating license for the Independent Spent Fuel Storage Installation. License Condition 19 required Calvert Cliffs to confirm in writing that procedures to implement the activities described in the Aging Management Programs (submitted in Reference 2) are in place, that appropriate references to the Aging Management Programs are in place, and the procedures will remain in place for the period of extended operation.

This letter confirms that Calvert Cliffs has met the stated conditions and is in compliance with License Condition 19 of the renewed Independent Spent Fuel Storage Installation license.

There are no regulatory commitments contained in this correspondence.
