SECTION C – STATEMENT OF WORK

C.1 STATEMENT OF WORK

A. Introduction

Under this contract, the contractor shall provide thorough, current, and timely summary and compilation of news stories along with an archive that is searchable by keyword and date. The contractor services shall include a daily news briefing/summary offering staff a thorough, current and timely compilation of news stories relevant to the agency's mission with an archive that is searchable by keyword and date. The services shall also provide social media measurement services to aid in accessing the agency's social media position.

B. Background

As stated in the U.S. Nuclear Regulatory Commission's (NRC) Management Directive 5.5, Public Affairs Program, the NRC Office of Public Affairs (OPA) staff is required to "keep NRC management advised of public interest in proposed policies, programs, and projects so that public affairs actions may be developed and executed effectively, and to inform NRC decision-making." Further, "[OPA] informs senior NRC management of media coverage of interest to the agency. [OPA] provides to the Chairman, the Commission, the EDO, and senior management— (a) Early advice on public affairs strategies to deal effectively with the public on issues of interest; and (b) Information on external activities that may affect NRC interests."

NRC officials and staff must start each day fully informed about local, regional, national and international news that is of interest to, or could impact, the NRC. The NRC has been using an electronic news retrieval service and will continue to require the service going forward. Additionally, as the NRC's social media presence has grown, and as social media increasingly is used as an information source by the public, the need for the agency to monitor and measure social media has also increased.

C. Objective

The contractor shall provide all personnel, equipment, supplies, facilities, supervision, and other items and non-personal services necessary to perform electronic news retrieval, news summary creation by human editor and social media data collection services as defined in this Statement of Work, except for those items specified as Government-furnished property and services. The objective is to provide a thorough, current, and timely narrative summary and compilation of news stories, with a searchable archive, as well as a social media dashboard.

D. Scope of Work

Electronic News Summary

NRC requires an electronic news monitoring and retrieval service that creates a list of topics in a table of contents, a human-written and human-edited daily summary of each identified news article, that provides a link to the actual print and broadcast news stories that are summarized, and, additionally, provides the full text of the news articles. The full text should be accessible via hyperlink and also be included as an addition to the summary document. The average briefing packet consists of approximately five pages of narrative and a table of contents, not including the full text of all the articles.

There is an average of 50 individual daily clippings both foreign and domestic each day on an average of 25 different topics that are used for the electronic news monitoring. The human editor using professional judgment must review the articles to ensure relevance, eliminate redundancies and write a summary of each, grouped by topic. The summary must include links and should provide enough context that readers can quickly grasp the general content and tone of the article. Articles that don't have substantially different content can be characterized in the summary with just a link. Each article, however, must be listed individually in the package. The contractor will not be required to summarize a subset of articles.

The contractor shall find and review articles and broadcasts from all major (and most smaller) daily newspapers, national and local television, newsweeklies, magazines and journals, internet sites, specialty press, international news sources covering nuclear activities and blogs. This includes national, regional and local coverage, wire services and key international English-language media outlets including international wire services, as well as relevant blogs, magazines, and trade or specialty press. This shall not only include online publications of daily news but also relevant stories found in the hardcopy outlets.

The contractor shall conduct the search for relevant articles using keywords and other means to identify news on topics directly related to the NRC, the nuclear industry both domestic and foreign, and other related topics of interest such as energy, the environment, labor, the federal government, emergency response, cybersecurity, etc. The contractor may need to adjust keywords and search queries to reflect current events.

The news in the daily briefing package must be current, occurring in the preceding 24 hours, and there should be a very low incidence of missed or day-old stories. The contractor shall respond to email follow-up from the agency for missed clips or other issues within one hour. When links point to content on subscription-based sites, the NRC may at its discretion subscribe. For broadcast stories in which reviewing the actual audio/video would be particularly useful, the contractor shall provide a link to available "video clips" that stream to the reader's desktop.

The contractor shall quickly accommodate changes to the package based on the changing needs of the NRC, including adding missed news clips, last minute changes to topics to be covered, deadlines, and the format of the package. The contractor shall also be flexible to respond to occasional special requests from OPA to provide news clips on a fast-breaking event that impacts the NRC. (Note: This is a rare occurrence, however, the capability to quickly expand must exist.)

The contractor shall also cover news of interest of the NRC. News of interest to the NRC means all coverage from the sources impacting the nuclear regulatory activities of the NRC including but not limited to regulation and guidance-rulemaking, policymaking, licensing, decommissioning, certification, research, oversight and enforcement, security, and emergency preparedness and response. In addition to news around the NRC, the news summary shall mention other topics programs and policies outside of those that either explicitly mention the NRC or directly relate to the agency's regulatory activities. For example, the contractor shall include articles regarding international nuclear matters, articles that involve other government entities such as the Environmental Protection Agency (EPA), Department of Energy (DOE), Federal Emergency Management Agency (FEMA), Occupational Safety and Health Administration (OSHA) and Department of Homeland Security (DHS) whose regulations, policies and / or activities may impact operations at the NRC, stories that involve a topic that

impacts all federal employees but does not pertain to nuclear activities (i.e. government shutdown) and articles about security and radiation. The audience is all NRC employees, approximately 4,000 individual readers.

The news summary must be posted to an IP-protected address accessible through the agency's Intranet by 7 a.m. during federal work days and sent via email to identified key officials. The summary must include news from weekends and Federal holidays in the next issue of the briefing.

The IP-protected website shall encompass a secure site-to site virtual private network for secure communication over the Internet, following the guidance provided by the National Institute of Technology under Special Publication 800-11 3, Guide to SSL VPNs for NRC review and approval. The offeror shall also propose an enclave with the appropriate isolation from other customers and within their corporate network to show an acceptable level of security and establish network trust between the contractor and the NRC enclaves. All encryption capability proposed, either in software, firmware or hardware must have use cryptographic algorithms tested and validated against the criteria established by the National Institute of Standards and Technology (NIST) Federal Information Processing Standard (FIPS) 140-2 requirement, accompanied with validation certificate(s) located on the NIST validation library.

Electronic News Summary Archives

The contractor shall ensure that all briefing packages (entire daily reports) are archived and searchable by date and keyword. The contractor shall archive in in such a way that people can view the entire report of any past day. The contractor shall ensure that the archive remains viable for the life of the contract. At the end of the contract, the contractor shall deliver the archive to the COR in a format (such as Microsoft Word or Adobe .pdf) that NRC can keep in-house on an internal NRC site or directory for use by NRC employees.

Social Media Dashboard

The contractor shall provide a social media electronic dashboard that collects and displays social media statistics according to relevant factors, such as frequency, audience size and source i.e. Twitter, Facebook, blog. The social media dashboard shall provide individual log ins to not more than six selected NRC staff from the Office of Public Affairs. The contractor shall update the dashboard daily (on federal work days) by 9 a.m., with data related to social media mentions of the NRC and related topics, and the identified audience and reach. The dashboard will be made available through a secure link. The dashboard shall allow for the NRC to run customized reports of its own choosing. The contractor shall not analyze the data nor to engage on social media on behalf of the agency.

The contractor shall also provide initial orientation and training regarding use of the dashboard development of customized reports to not more than six NRC employees. Specific room, date and locations will be coordinated between the contractor and the COR after contract award.

E. Deliverables

1. The contractor shall provide a daily news briefing/summary by 7:00 a.m. (Eastern Time) on weekdays except on Federal holidays. The contractor shall provide news clips on fast-breaking events that impact the NRC on an as-needed basis. The contractor shall provide an archive of daily news briefings/summaries.
2. The contractor shall provide a social media dashboard that is populated daily by 9:00 a.m. (Eastern Time) on weekdays except Federal Holidays. The platform shall be in electronic format with the capability of downloading/printing relevant customized reports.

F. Place of Performance

The place of performance is at the contractor's discretion. NRC does not intend to provide any space for the contractor.

G. Meetings

The contractor shall attend a post award (kick off meeting) conference convened by the contracting officer. This meeting shall take place at NRC Headquarters located in Rockville, MD. Specific room, date and locations will be provided to the contractor after contract award. The meeting shall take place not later than two weeks after contract award.

The CO, CORs, and other Government personnel, as appropriate, may request meetings (which will take place via conference calls) with the contractor to review the contractor's performance. These will occur only when necessary, and not more than monthly. At these meetings the CO will apprise the contractor of how the government views the contractor's performance and the contractor will apprise the Government of problems, if any, being experienced. Appropriate action shall be taken to resolve outstanding issues. These meetings shall be at no additional cost to the Government. (x) Electronic funds transfer (EFT) banking information.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(a) The Government may extend the term of this contract by written notice to the Contractor before the contract expires; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 10 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed four years.

F.6 52.227-17 RIGHTS IN DATA--SPECIAL WORKS. (DEC 2007)

(a) Definitions. As used in this clause--

Data means recorded information, regardless of form or the media on which it may be recorded. The term includes technical data and computer software. The term does not include information incidental to contract administration, such as financial, administrative, cost or pricing, or management information.

Unlimited rights means the rights of the Government to use, disclose, reproduce, prepare derivative works, distribute copies to the public, and perform publicly and display publicly, in any manner and for any purpose, and to have or permit others to do so.

(b) Allocation of Rights. (1) The Government shall have--

(i) Unlimited rights in all data delivered under this contract, and in all data first produced in the performance of this contract, except as provided in paragraph (c) of this clause.

(ii) The right to limit assertion of copyright in data first produced in the performance of this contract, and to obtain assignment of copyright in that data, in accordance with paragraph (c)(1) of this clause.

(iii) The right to limit the release and use of certain data in accordance with paragraph (d) of this clause.

(2) The Contractor shall have, to the extent permission is granted in accordance with paragraph (c)(1) of this clause, the right to assert claim to copyright subsisting in data first produced in the performance of this contract.

(c) Copyright--(1) Data first produced in the performance of this contract. (i) The Contractor shall not assert or authorize others to assert any claim to copyright subsisting in any data first produced in the performance of this contract without prior written permission of the Contracting Officer. When copyright is asserted, the Contractor shall affix the appropriate copyright notice of 17 U.S.C. 401 or 402 and acknowledgment of Government sponsorship (including contract number) to the data when delivered to the Government, as well as when the data are published or deposited for registration as a published work in the U.S. Copyright Office. The Contractor grants to the Government, and others acting on its behalf, a paid-up, nonexclusive, irrevocable,

worldwide license for all delivered data to reproduce, prepare derivative works, distribute copies to the public, and perform publicly and display publicly, by or on behalf of the Government.

(ii) If the Government desires to obtain copyright in data first produced in the performance of this contract and permission has not been granted as set forth in paragraph (c)(1)(i) of this clause, the Contracting Officer shall direct the Contractor to assign (with or without registration), or obtain the assignment of, the copyright to the Government or its designated assignee.

(2) Data not first produced in the performance of this contract. The Contractor shall not, without prior written permission of the Contracting Officer, incorporate in data delivered under this contract any data not first produced in the performance of this contract and that contain the copyright notice of 17 U.S.C. 401 or 402, unless the Contractor identifies such data and grants to the Government, or acquires on its behalf, a license of the same scope as set forth in paragraph (c)(1) of this clause.

(d) Release and use restrictions. Except as otherwise specifically provided for in this contract, the Contractor shall not use, release, reproduce, distribute, or publish any data first produced in the performance of this contract, nor authorize others to do so, without written permission of the Contracting Officer.

(e) Indemnity. The Contractor shall indemnify the Government and its officers, agents, and employees acting for the Government against any liability, including costs and expenses, incurred as the result of the violation of trade secrets, copyrights, or right of privacy or publicity, arising out of the creation, delivery, publication, or use of any data furnished under this contract; or any libelous or other unlawful matter contained in such data. The provisions of this paragraph do not apply unless the Government provides notice to the Contractor as soon as practicable of any claim or suit, affords the Contractor an opportunity under applicable laws, rules, or regulations to participate in the defense of the claim or suit, and obtains the Contractor's consent to the settlement of any claim or suit other than as required by final decree of a court of competent jurisdiction; and these provisions do not apply to material furnished to the Contractor by the Government and incorporated in data to which this clause applies.

F.7 2052.209-72 CONTRACTOR ORGANIZATIONAL CONFLICTS OF INTEREST. (JAN 1993)

(a) Purpose. The primary purpose of this clause is to aid in ensuring that the contractor:

(1) Is not placed in a conflicting role because of current or planned interests (financial, contractual, organizational, or otherwise) which relate to the work under this contract; and

(2) Does not obtain an unfair competitive advantage over other parties by virtue of its performance of this contract.

(b) Scope. The restrictions described apply to performance or participation by the contractor, as defined in 48 CFR 209.570-2 in the activities covered by this clause.

(c) Work for others.

(1) Notwithstanding any other provision of this contract, during the term of this contract, the contractor agrees to forego entering into consulting or other contractual arrangements with

any firm or organization the result of which may give rise to a conflict of interest with respect to the work being performed under this contract. The contractor shall ensure that all employees under this contract abide by the provision of this clause. If the contractor has reason to believe, with respect to itself or any employee, that any proposed consultant or other contractual arrangement with any firm or organization may involve a potential conflict of interest, the contractor shall obtain the written approval of the contracting officer before the execution of such contractual arrangement.

(2) The contractor may not represent, assist, or otherwise support an NRC licensee or applicant undergoing an NRC audit, inspection, or review where the activities that are the subject of the audit, inspection, or review are the same as or substantially similar to the services within the scope of this contract (or task order as appropriate) except where the NRC licensee or applicant requires the contractor's support to explain or defend the contractor's prior work for the utility or other entity which NRC questions.

(3) When the contractor performs work for the NRC under this contract at any NRC licensee or applicant site, the contractor shall neither solicit nor perform work in the same or similar technical area for that licensee or applicant organization for a period commencing with the award of the task order or beginning of work on the site (if not a task order contract) and ending one year after completion of all work under the associated task order, or last time at the site (if not a task order contract).

(4) When the contractor performs work for the NRC under this contract at any NRC licensee or applicant site,

(i) The contractor may not solicit work at that site for that licensee or applicant during the period of performance of the task order or the contract, as appropriate.

(ii) The contractor may not perform work at that site for that licensee or applicant during the period of performance of the task order or the contract, as appropriate, and for one year thereafter.

(iii) Notwithstanding the foregoing, the contracting officer may authorize the contractor to solicit or perform this type of work (except work in the same or similar technical area) if the contracting officer determines that the situation will not pose a potential for technical bias or unfair competitive advantage.

(d) Disclosure after award.

(1) The contractor warrants that to the best of its knowledge and belief, and except as otherwise set forth in this contract, that it does not have any organizational conflicts of interest as defined in 48 CFR 2009.570-2.

(2) The contractor agrees that if, after award, it discovers organizational conflicts of interest with respect to this contract, it shall make an immediate and full disclosure in writing to the contracting officer. This statement must include a description of the action which the contractor has taken or proposes to take to avoid or mitigate such conflicts. The NRC may, however, terminate the contract if termination is in the best interest of the Government.

(3) It is recognized that the scope of work of a task-order-type contract necessarily encompasses a broad spectrum of activities. Consequently, if this is a task-order-type

contract, the contractor agrees that it will disclose all proposed new work involving NRC licensees or applicants which comes within the scope of work of the underlying contract. Further, if this contract involves work at a licensee or applicant site, the contractor agrees to exercise diligence to discover and disclose any new work at that licensee or applicant site. This disclosure must be made before the submission of a bid or proposal to the utility or other regulated entity and must be received by the NRC at least 15 days before the proposed award date in any event, unless a written justification demonstrating urgency and due diligence to discover and disclose is provided by the contractor and approved by the contracting officer. The disclosure must include the solicitation Statement of Work, the dollar value of the proposed contract, and any other documents that are needed to fully describe the proposed work for the regulated utility or other regulated entity. NRC may deny approval of the disclosed work only when the NRC has issued a task order which includes the technical area and, if site-specific, the site, or has plans to issue a task order which includes the technical area and, if site-specific, the site, or when the work violates paragraphs (c)(2), (c)(3) or (c)(4) of this section.

(e) Access to and use of information.

(1) If, in the performance of this contract, the contractor obtains access to information, such as NRC plans, policies, reports, studies, financial plans, internal data protected by the Privacy Act of 1974 (5 U.S.C. Section 552a (1988)), or the Freedom of Information Act (5 U.S.C. Section 552 (1986)), the contractor agrees not to:

(i) Use this information for any private purpose until the information has been released to the public;

(ii) Compete for work for the Commission based on the information for a period of six months after either the completion of this contract or the release of the information to the public, whichever is first;

(iii) Submit an unsolicited proposal to the Government based on the information until one year after the release of the information to the public; or

(iv) Release the information without prior written approval by the contracting officer unless the information has previously been released to the public by the NRC.

(2) In addition, the contractor agrees that, to the extent it receives or is given access to proprietary data, data protected by the Privacy Act of 1974 (5 U.S.C. Section 552a (1988)), or the Freedom of Information Act (5 U.S.C. Section 552 (1986)), or other confidential or privileged technical, business, or financial information under this contract, the contractor shall treat the information in accordance with restrictions placed on use of the information.

(3) Subject to patent and security provisions of this contract, the contractor shall have the right to use technical data it produces under this contract for private purposes provided that all requirements of this contract have been met.

(f) Subcontracts. Except as provided in 48 CFR 209.570-2, the contractor shall include this clause, including this paragraph, in subcontracts of any tier. The terms contract, contractor, and contracting officer, must be appropriately modified to preserve the Government's rights.

(g) Remedies. For breach of any of the above restrictions, or for intentional nondisclosure or

misrepresentation of any relevant interest required to be disclosed concerning this contract or for such erroneous representations that necessarily imply bad faith, the Government may terminate the contract for default, disqualify the contractor from subsequent contractual efforts, and pursue other remedies permitted by law or this contract.

(h) Waiver. A request for waiver under this clause must be directed in writing to the contracting officer in accordance with the procedures outlined in 48 CFR 2009.570-9.

(i) Follow-on effort. The contractor shall be ineligible to participate in NRC contracts, subcontracts, or proposals therefor (solicited or unsolicited) which stem directly from the contractor's performance of work under this contract. Furthermore, unless so directed in writing by the contracting officer, the contractor may not perform any technical consulting or management support services work or evaluation activities under this contract on any of its products or services or the products or services of another firm if the contractor has been substantially involved in the development or marketing of the products or services.

(1) If the contractor under this contract, prepares a complete or essentially complete solicitation Statement of Work or specifications, the contractor is not eligible to perform or participate in the initial contractual effort which is based on the solicitation Statement of Work or specifications. The contractor may not incorporate its products or services in the solicitation Statement of Work or specifications unless so directed in writing by the contracting officer, in which case the restrictions in this paragraph do not apply.

(2) Nothing in this paragraph precludes the contractor from offering or selling its standard commercial items to the Government.

(b) If one or more of the key personnel, for whatever reason, becomes, or is expected to become, unavailable for work under this contract for a continuous period exceeding 30 work days, or is expected to devote substantially less effort to the work than indicated in the proposal or initially anticipated, the contractor shall immediately notify the contracting officer and shall, subject to the concurrence of the contracting officer, promptly replace the personnel with personnel of at least substantially equal ability and qualifications.

(c) Each request for approval of substitutions must be in writing and contain a detailed explanation of the circumstances necessitating the proposed substitutions. The request must also contain a complete resume for the proposed substitute and other information requested or needed by the contracting officer to evaluate the proposed substitution. The contracting officer and the COR shall evaluate the contractor's request and the contracting officer shall promptly notify the contractor of his or her decision in writing.

(d) If the contracting officer determines that suitable and timely replacement of key personnel who have been reassigned, terminated, or have otherwise become unavailable for the contract work is not reasonably forthcoming, or that the resultant reduction of productive effort would be so substantial as to impair the successful completion of the contract or the service order, the contract may be terminated by the contracting officer for default or for the convenience of the Government, as appropriate. If the contracting officer finds the contractor at fault for the condition, the contract price or fixed fee may be equitably adjusted downward to compensate the Government for any resultant delay, loss, or damage.

F.9 2052.222-70 NONDISCRIMINATION BECAUSE OF AGE (JAN 1993)

foreign government, agency, firm, corporation or person; or

(4) Any person who is not a U.S. citizen.

(b) A U.S. company determined to be under FOCI is not eligible for facility clearance (FCL). If a company already has an FCL, the FCL shall be suspended or revoked unless security measures are taken to remove the possibility of unauthorized access to classified information.

(c) For purposes of this clause, subcontractor means any subcontractor at any tier and the term "contracting officer" shall mean NRC contracting officer. When this clause is included in a subcontract, the term "contractor" shall mean subcontractor and the term "contract" shall mean subcontract.

(d) The contractor shall complete and submit and SF-328, DD-441 and DD-441-1 forms, prior to contract award. The information contained in these forms may be used in making a determination as to whether a contractor is eligible to participate in the National Industrial Security Program and have a facility security clearance.

(e) The contractor shall immediately provide the contracting officer written notice of any changes in the extent and nature of FOCI over the contractor which would affect the answers to the questions presented in SF-328, "Certificate Pertaining to Foreign Interest". (h) Information submitted by the contractor or any affected subcontractor as required pursuant to this clause shall be treated by NRC to the extent permitted by law, as business or financial information submitted in confidence to be used solely for purposes of evaluating FOCI.

(i) The requirements of this clause are in addition to the requirement that a contractor obtain and retain the security clearances required by the contract. This clause shall not operate as a limitation on NRC's rights, including its rights to terminate this contract.

(j) The contracting officer may terminate this contract for default either if the contractor fails to meet obligations imposed by this clause, e.g., provide the information required by this clause, comply with the contracting officer's instructions about safeguarding classified information, or make this clause applicable to subcontractors, or if, in the contracting officer's judgment, the contractor creates a FOCI situation in order to avoid performance or a termination for default. performance of the contract, cannot, or chooses not to, avoid or mitigate the FOCI problem. responsibility under this clause.
