On June 4, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Hatch Nuclear Plant. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report (IR) documents the inspection results that were discussed on June 16, 2015, with Mr. David Vineyard, Hatch Nuclear Plant Site Vice President; yourself; members of the Hatch security staff; and Southern Nuclear Operating Co., Inc. security staff.

No NRC-identified or self-revealing findings were identified during this inspection.
